2.2 At the consultation closing deadline of 5.00pm on Monday 2 November 2015, a total of 26 submissions had been received. In the mail on the morning of Tuesday 3 November 2015, a further six submissions were received.

2.3 Setting of Fees for Functions under the Food Act 2014

2.4 At the consultation closing deadline of 5.00pm on Monday 2 November 2015, one submission had been received. In the mail on the morning of Tuesday 3 November 2015, a further two submissions were received. One of these submissions is from multiple (16) food premise owners.

2.5 Late Submissions

- 2.6 As agreed with Council in confirming the process for public consultation, all submissions received in the mail on the morning following the consultation closing deadline are accepted and not treated as late submissions.
- 2.7 At the time of preparing this Agenda, there have been no late submissions received. In the event late submissions are received, they will be circulated to Council under separate cover. Council must decide whether or not to accept and include any late submissions for consideration as part of its deliberations.
