Commentary

2.1 Draft 2015-2025 Long Term Plan

- 2.2 At the consultation closing deadline of 5.00pm on Friday 1 May 2015, a total of 25 submissions had been received.
- 2.3 Over the weekend of 2/3 May, and on the morning of Monday 4 May 2015, a further five submissions were received. As agreed with Council in confirming the process for development of the 2015-2025 Long Term Plan, all submissions received in the mail on Monday 4 May are accepted and not treated as late submissions.

2.4 Late Submissions

- 2.5 At the time of preparing this Agenda, there has been one late submission received (Submission No. 031). A copy of that Submission has been included in the Submission Booklet circulated to Council.
- 2.6 Council must decided whether or not to accept the late submission and include it for consideration as part of its deliberations.
