## **Purpose**

### 2.1 Consultation Document - 2018-2028 Long Term Plan

- 2.2 At the consultation closing deadline of midnight on Friday 4 May 2014, a total of 112 submissions had been received.
- 2.3 Over the weekend of 5/6 May, and on the morning of Monday 7 May 2018, a further four late submissions were received. Two of these (Submissions 113 and 114) were included in the Submission Booklet as distributed separately. The other two (Submissions 115 and 116) are attached to and form part of this business paper. None of these Submitters wish to be heard at a Hearing.
- 2.4 As agreed with Council in confirming the process for development of the 2018-2028 Long Term Plan, all submissions received in the mail on Monday 7 May, whilst received outside the consultation period, are accepted and not treated as late submissions.
- 2.5 On Wednesday 9 May 2018, a further late submission (Submission 117) was received in the mail. This submission is also attached to and forms part of this business paper. This submitted does not wish to be heard at a Hearing.

## 2.6 <u>Late Submissions</u>

2.7 At the time of preparing this Agenda, other than the submissions referred to above, no further late submissions have been received. In the event any further submissions are received, these will be provided to the Council under separate
